

CPE Master Premium – AGILITY

Send Premiums for review to: premiums@cpe.dog

- If a premium is sent more than 6 months before the trial date, the entry method must have an opening date no earlier than 6 months before the trial date.
- Do not leave blank lines/rows or cells. Delete blank rows, merge, or shade blank cells.
- Items listed are required to be in the premium. The “Cover Page” table is required to be in the same order per the template and only the black print may be altered except for the wording for entry methods must remain per the template.
- Items in **RED** are directions for the club; delete the red wording as the club’s information is added.
- In the premium table which has the Judge’s information, is required, and runs held for volunteers is optional. The information in black may be deleted.
- The entry form from the CPE ID number through the jump heights must remain as the template.
- Premiums are due for review **no later than 4 months prior to the trial date**, or when the trial approved email has been received.
- Opening dates must be at least 4 weeks later than the date sent to CPE for review. This allows for review, revisions, and re-review of the premium.
- Once the premium has been received then CPE will review premiums within 5 business days (Monday through Thursday, unless the office is closed), and email what needs to be changed or signify the premium has been approved and may be published by the club. Check the contact us page for office closures and plan accordingly. Once approved, the premium will be added to the CPE website events page.
- Ensure the premium has been proofread for club information, dates, entry fees, etc. BEFORE sending to CPE. CPE is not responsible for mistakes on information pertinent to the club. CPE reviews the document for information required by CPE and approved on the trial application.
- Be sure to change the **whole document to black for the final premium** prior to sending to CPE for review. Once approved, CPE will post to the CPE events page which is usually within 7 days.
- The entry methods in Table 1 will be required to be stated on all premiums. The Trial Secretary will determine if it is necessary to contact the competitor if entries are received prior to the opening date.
- Only one (1) entry method may be used per trial. The wording in the table must remain as listed except for the information about destroying checks as the club may return the checks if that is the policy. The dates must be added in the respective areas.
- Delete this page before sending the premium to CPE for review once the information has been added to the actual premium.

Table 1: Entry Methods

Entry Method – First Received without an opening date.	Entries may be mailed/received at any time once the premium has been published.
Entry Method – First Received with an Opening Date. (add date).	Entries may be received at any time on or after the opening date. Entries received before the opening date will be destroyed. Any hand delivered entries will not be accepted on or before the opening date, which is day 1, however hand delivered entries will be accepted on day 2 or later. Note: Clubs may change the previous sentence and may elect not to accept hand delivered entries. Note: Overnight envelopes must have the recipient’s signature waiver signed or the envelope may be refused or delayed.

NOTICE TO EXHIBITORS

- *The safety of the dogs is the primary concern so by entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- *Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.
- *It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may at the discretion of the Trial Committee, be asked to leave the trial site. If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.
- *Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- *Exhibitors are responsible for complete, accurate, and legible information on the entry forms. Any illegible or incomplete entries will not be entered in the trial.
- *Refunds (less \$6.00 administrative fee and applicable CPE Recording fees per day (\$1.80 per run entered)) of Pre-Entries withdrawn after the closing date will be considered on a case-by-case basis by the GLOC board. Request for refunds must be submitted via email to gloctrialdirector@gmail.com within 7 days of the last day of the rial. Include rationale and any supporting documentation. Decisions will be provided after the next GLOC board meeting (typically the first Thursday of the month).
- * Agility Gate will be used for check-in and monitoring the run order. Every effort will be made to space dogs run by the same handler in the same class. A paper copy of the run order will be posted but not updated for day of show conflicts.

<p>The complex, previously named Abbott Sports Complex, is 1.3 miles north of US-6/Cornhusker Hwy on N 70th St.</p> <p>From the East and Northeast: Exit I-80 at US-6 toward Waverly/E Lincoln. Turn left onto US-6 W. Keep left to stay on US-6 over overpass. Turn right at light onto N 70th St. In 1.3 miles, complex is on the right.</p> <p>From the North and Northwest: Exit I-80 at Exit 405 for US-77 N/56th St. Turn right onto N 56th St. In 0.2 miles, turn left onto Arbor Rd, then in 1 mile turn right onto N 70th St. Sports complex is 0.4 miles on left. NOTE: Arbor Rd is paved but narrow with considerable heavy truck damage. Alternate route is to continue on N 56th St until road T's at US-6. Turn left onto US-6 and in 1 mile turn left on to N 70th St. In 1.3 miles, complex is on the right.</p>
