KEY AGREEMENT FOR ACTIVITY PASS HOLDERS

The Greater Lincoln Obedience Club (GLOC) Key agreement for Activity Pass Holders entitles the club member access to the GLOC building at 5740 Johanna Road, Lincoln, Nebraska for a period of the calendar year. To be eligible for a key, members must be an Activity Pass holder for one year, in good standing, have 30 required volunteer hours, and current on all payments.

The key holder agrees:

1. To use the building for individual dog training purposes only. *
2. To use the facility for noncommercial activities only, unless given prior permission by the GLOC Board of Directors. *
3. To leave the building in the condition it was in at the time of entrance, minus normal wear and tear.
4. To secure the building upon leaving, including but not limited to returning any equipment used by the key holder for practices to its storage location, closing and locking all doors and windows, and turning off all lights.
5. To relinquish the use of equipment and facilities to any club scheduled or sponsored class(es), seminar(s), or other club activities upon notice or request.
6. To keep all dogs under control while at the facility.
7. To obey the rules and regulations of GLOC and the rules and regulations of the facility. Failure to do so will result in key revocation and immediate key return. If key is not immediately returned, key holder will be liable and billed for building re-key expenses and all new key distribution expenses.

*The key is for you and you alone. If there is not an "OPEN" class at the building and you wish to bring people in building to train (see 1 & 2 above) – regardless if they are members or non-members – they need to sign in and pay \$5, unless they have an Activity Pass. You will be responsible. If you are in the building and members come into use the building – you will be responsible to make sure they have a key. If they do not, they will need to leave when you leave and you need to make sure the building is secure.

If there is a class going on in one of the Rings – the instructor has the right to use both rings. Per the instructor agreement, the instructor has use of a ring 30 minutes before and/or 30 minutes after class if there is time allotted. If the instructor is not using said rings, people need to stay out of said rings 20 minutes before classes start.
