

NOTICE TO EXHIBITORS

- Dogs must be at least 6 months of age on the day of the trial.
- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and their dogs are familiar with the odors.
- Entry fees will not be refunded after the closing date or in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- Exhibitors are responsible for complete, accurate, and legible information on the entry forms; illegible or incomplete entries cannot be entered in the show.
- No prong collars; and no electronic or training collar devices (this includes shock & bark collars) are allowed on the grounds of a CPE trial.
- Boxed lunch will be available for purchase in a pre-order email sent out pre trial.

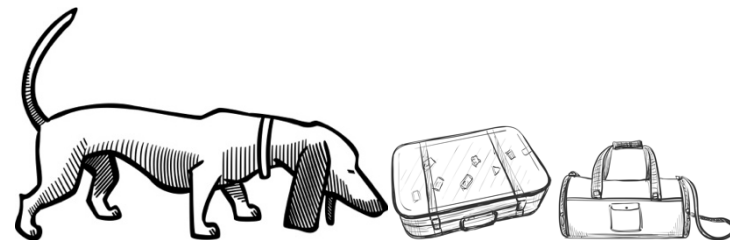
